

# SIX SENSES IBIZA COVID-19 POLICY

## THANK YOU FOR STAYING WITH US

In order to guarantee a safe environment for everyone, Six Senses Ibiza not only committed to full compliance with the restrictions applied by the local government but also follows strict internal guidelines, both to be modified if necessary.

### General information

**Socialdistance:** 1,5m

#### Masks:

- Outside: whenever you cannot guarantee the social distance of 1,5m
- Inside: mandatory

#### Rooms:

- Sanitized as by local standards
- Used of additional materials is reduced to avoid touch points

#### Restaurants/Bars

- must close at 2.00 am. Dancing is prohibited.
- Indoor: 6 persons seated per table (50% max. occupancy)
- Outdoor: 12 persons seated per table (no occupancy limits)
- Bars can be used until 0.00 am in groups of 2 persons.
- Prebooking is recommended

#### Events:

- Indoor: 50 persons
- Outdoor: 120 persons
- In case all the group has Green Pass (full vaccinate or negative PCR test within 24h)
  - Indoor: 100 persons
  - Outdoor: 200 persons

#### Library

- No occupancy limit while social distancing can be respected. Use of mask is mandatory.

#### Spa

- Treatment rooms will be deep cleaned between each treatment.
- Sauna and steam bath are available upon appointment and limited to single guest
- slots or pairs (when staying together), sanitization will take place after each use.

#### Sports:

- Outdoors: max. 30 persons
- In court: max. 20 persons
- Contact sports: 10 persons

#### Gym

- Masks are mandatory when moving around gym facilities and should be worn when using the machines.
- Capacity will be restricted to 75% of maximum occupancy.
- Guests are required to sanitize equipment after usage.
- Changing rooms are limited to 50% of the maximum occupancy.

- High intensity sports activities in room for a maximum of 20 people. Other indoor activities up to 25 people.
- Contact sport activities can be organized at our Boxing Ring up to 10 persons.

### **Pool deck area**

- Sunbed layout will comply with social distancing standards.
- Masks are not mandatory while bathing. It is neither mandatory while relaxing on your sunbeds when social distancing is respected.

### **Swimming Pools**

- Pool cleaning and control will be following health and safety regulations.
- Common areas and showers will be disinfected on a frequent basis.
- The maximum capacity of pools is monitored and controlled by the beach deck attendant on duty.

### **Public areas**

- Indoor public areas are limited to 75% of max. occupancy.
- Masks are not mandatory in outdoor public areas, but it is required when walking through common areas.

### **Grow With Six Senses**

- Social distancing: 1,5 m
- Limited to 75% max. occupancy
- Pre advisal is required and parents are asked not to enter the facilities.
- Toys are disinfected
- Hosts will wear a mask and maintain social distancing whenever possible. Whenever possible outdoor areas will be used specially while eating.
- Babysitters are highly trained to guarantee the safety and quality of the service. Babysitters must use masks at any times. Shoes to be left outside.
- Kids older than 6 should wear masks.
